Finance

2. RESOLVED that the Board of Trustees approve the salary schedule movement for Christine Dorchak from column J22 (\$135,359) to column L22 (\$141,907), effective February 1, 2025.
3. RESOLVED that the Board of Trustees accept a donation from Barbara and Gary Sanders for the planting of a tree through the Tuckahoe Teachers Association in memory of Board of Trustee, Timothy M. Gilmartin and further request permission to plant this tree on school grounds.
