MINUTES – ANNUAL MEETING & TRUSTEE ELECTION  
May 18, 2021**

The Tuckahoe School Board of Trustees held their Annual Meeting & Trustee Election on May 18, 2021. Lauri Lenahan, Chairperson of the Annual Meeting & Trustee Election, called the meeting to order at 7:00 a.m. One hundred seventy-two (172) votes were cast with the following results:

**PROPOSITION #1**

RESOLVED that the Board of Trustees of the Tuckahoe Common School District at Southampton, Town of Southampton, County of Suffolk, be authorized and directed to expend the sum set forth in their proposed budget for 2021-2022 in the total amount of \$23,137,474 and to levy the necessary tax therefor.

**PROPOSITION #2**

SHALL the Board of Trustees be authorized to expend a sum not to exceed \$413,706 from the 2006/2007 Capital Reserve Fund established on March 2007, and a sum not to exceed \$600,000 from the Facilities Improvement Program 2020 Capital Reserve Fund established in June 2020 for the purpose of the installation of new Acrylabs roof system, installation of new GAF shingle roof system; painting of interior of building; and windows replacement/renovation, all of the foregoing to include all labor, materials, equipment, apparatus, and incidental costs associated therewith

**PROPOSITION #3**

SHALL the Board of Trustees be authorized to enter into a new tuition agreement with Southampton Union Free School District for the 2021-2022 through 2025-2026 school years for the education of Tuckahoe Common School District 9<sup>th</sup> through 12<sup>th</sup> grade.

**PROPOSITION #4**

SHALL the Board of Trustees of the Tuckahoe Common School District at Southampton, Town of Southampton, County of Suffolk, be authorized and directed to levy a sum of \$56,650 for the District's participation in the Southampton Youth Association.
